Prepare for the **EU's Corporate Sustainability Due Diligence Directive (CSDDD)** and lay the foundation for compliance with other due diligence and reporting requirements. Participants will benefit from **expert insight, peer learning** and **one-to-one advice**.

Programme Structure /

Phase 1

Understanding Sustainability Due Diligence Regulation

- Get clear about the substantive requirements of the CSDDD.
- Examine the **EU Forced Labour Regulation (EUFLR)**, other issue-specific due diligence legislation, and emerging national requirements.
- Understand the links between due diligence and reporting expectations, especially the **EU Sustainability Reporting Standards (ESRS)**.

Phase 2

Building an Effective and Integrated Response

- Consider how to drive integrated organisational approaches to due diligence, reporting and regulatory requirements.
- Learn about governance, accountability and decision-making processes that can work across functions, making efficient use of existing data and systems.
- Be “future fit” for new related regulatory requirements and stakeholder expectations.

Phase 3

Reflection, Next Steps and Shared Learning

- Work with peers and Shift to crystallise learnings and headline guidance for businesses.
- Engage one-to-one with Shift experts on next steps or a key challenge your company wishes to explore in more depth.
- Contribute to an anonymized public report highlighting emerging practices and key takeaways from the clinic.

Participation and Company Commitment /

Companies will be asked to:



Nominate two lead participants who will attend the entire programme.



Involve additional colleagues, where appropriate, in sessions relevant to their roles.



Nominate a senior sponsor to participate in a peer discussion about the overall, cross-company lessons from the clinic.
